1. Credit Card Guarantee

A credit card is required in order to proceed to a reservation in Sea Containers Restaurant.

2. Menus

For groups larger than 8 we offer our Christmas Feast Menu/Christmas Premium Feast Menu/Christmas Day Set Menu/NYE Set Menu/Christmas Feast Brunch Menu, depending on the date of your reservation. Please note that the Feast menus are not served as a set course meal, but 'family style' and are designed for your group to share - the whole group is required to dine on the same menu. We require your preferred selection with a minimum of 14 days before your reservation date. Please note, almost all dietary requirements will be catered for.

3. Minimum Spend / Deposit

The Private Room can accommodate maximum of 22 people for breakfast, lunch or dinner. During the Festive period, a minimum spend of £2000 will apply to your reservation. This amount includes the room hire fee however; the service charge of 12.5% is excluded. There will be an early seating and a late seating available during Lunch and Dinner service. We will require a full deposit of the minimum spend plus the discretionary service charge 7 days prior to your reservation via a BACS Payment. Any extra charges on the night will need to be settled by cash or a credit/debit card present.

4. Table Allocations

Your table will be allocated to your party for two and half hours, however this can be extended with prior agreement. Upon booking, your preferences will be noted however, they are subject to availability

5. Final Numbers and Cancellation Policy

Confirmation of your booking/numbers is required 5 days prior to your reservation. In case of the party size decreasing on the day, the full preorder amount originally agreed will be charged. There will be no charge for cancellations made over 5 days in advance of your reservation. For bookings cancelled less than 5 days in advance, a cancellation fee of £25 per person will be charged. For a cancellation or no show on the day of the reservation, there will be a fee of the full minimum spend agreed.
